RANGE SAFETY RULES

YOUR GUNS:

1. GUNS MUST BE CARRIED WITH ACTIONS OPEN AND EMPTY
2. GUNS MUST NOT BE LOADED UNTIL ON STATION AND READY TO SHOOT
3. GUNS MUST HAVE A MINIMUM BARREL LENGTH OF 22"
4. A MAXIMUM OF TWO (2) SHELLS MAY BE LOADED AT ANY TIME
5. MAXIMUM SHOT SIZE IS 7 ½, NO MAGNUM LOADS, HIGH BASE HUNTING LOADS, OR STEEL SHOT OR TRACERS, NO 12 GA 3" SHELLS, AND NO BLACK POWDER LOADS ALLOWED WITHOUT PRIOR PERMISSION

YOUR ACTIONS:

ALL PARTICIPANTS AND OBSERVERS MUST CHECK IN AT THE OFFICE PRIOR TO GOING TO A FIELD

1. ALL PARTICIPANTS AND OBSERVERS MUST READ AND SIGN THE WAIVER AND RELEASE OF LIABILITY FORM AND THESE RANGE SAFETY RULES PRIOR TO ENTRY ONTO THE SHOOTING AREAS
2. EYE AND EAR PROTECTION IS MANDATORY ON OR NEAR THE RANGE
3. NO PRACTICE SWINGS OUTSIDE OF SHOOTING STATIONS
4. LOAD ONLY ONE SHELL PER TARGET, ONE FOR SINGLES, TWO FOR DOUBLES
5. SHOOT AT TARGETS ONLY, DO NOT SHOOT AT CHIPS OR ERRANT TARGETS
6. DO NOT APPROACH TRAP EQUIPMENT FOR ANY REASON – DO NOT GO DOWNRANGE FOR ANY REASON - REPORT MALFUNCTIONS TO RANGE STAFF IMMEDIATELY
7. ALL SKEET PULLERS AND ALL OTHER PERSONS MUST STAND BEHIND ANY SHOOTERS AT ALL TIMES – NO EXCEPTIONS!
8. NO BACK-UP SHOOTING IS ALLOWED (ONLY ONE SHOOTER MAY SHOOT AT EACH TARGET RELEASED)
9. NEVER SHOOT AT ANIMALS OR BIRDS OF ANY KIND WHILE ON THE RANGE

YOUR RESPONSIBILITIES:

1. IF YOU SEE AN UNSAFE SITUATION LEAVE THE AREA IMMEDIATELY AND REPORT IT TO RANGE STAFF – FAILURE TO OBSERVE RANGE SAFETY RULES MAY RESULT IN BEING DISQUALIFIED FROM THE RANGE!
2. PERSONS UNDER THE AGE OF 18 MUST BE ACCOMPANIED BY AN EXPERIENCED ADULT
3. NO ALCOHOL IS ALLOWED IN THE SHOOTING AREAS – ABSOLUTELY NO ALCOHOL CONSUMPTION IS ALLOWED BEFORE OR DURING SHOOTING
4. PARTICIPANTS AND OBSERVERS MUST SIGN A LIABILITY WAIVER PRIOR TO ENTRY TO SHOOTING AREAS

WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed participate in and to observe ANY ACTIVITY RELATED TO THE SHOOTING SPORTS, INCLUDING, BUT NOT LIMITED TO SHOTGUN TARGET SHOOTING AND RELATED ACTIVITIES on or near the Premises, (the "Activity"), I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in, or observation of others engaged in the Activity, and do hereby release and forever discharge STOCKTON TRAP AND SKEET CLUB, located at 4343 NORTH ASHLEY LANE STOCKTON CA, 95215, (the "Premises") their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in, or observation of others engaged in the aforementioned Activity, including traveling to and from an event or other activity related to this Activity.

I AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH TRAVELING TO AND FROM AS WELL AS PARTICIPATING IN AND OBSERVING THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO, PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH.
